Community Impact Councils: WIN-LA	Health Net invited WIN-LA to share updates and insights on the Community Impact Council (CIC) partnership. A CIC is designed to identify social issues at a community level and identify ways to improve on those identified issues. Sherri Patton (Project Director and Lead Champion, WIN-LA) and Vertise Suggs (Coordinator and Backbone Champion, WIN- LA) provided the committee with an overview of the partnership with Health Net to conduct focus groups for African American families and community-based organizations in South Los Angeles. Diversity, Equity, and Inclusion (DEI) Training Program	<ul> <li>Sharon Rushing (Senior Health Equity Specialist) reviewed Health Net's DEI trainings for providers and staff as required by DHCS. Committee provided feedback on the 4 trainings -</li> <li>Advancing Health Equity: Understanding Drivers and Increasing Accountability <ul> <li>Highlighted biases faced by individuals on Medi-Cal due to income challenges.</li> <li>Addressing literacy issues and assisting members in understanding medical forms and prescriptions is crucial.</li> <li>Need for medical professionals to have street-medicine training.</li> </ul> </li> <li>Language Assistance Program/Services and Health Literacy <ul> <li>Need to ensure that Spanish- language materials are accurately edited.</li> </ul> </li> <li>Cross-Cultural Communication and Competent Care for Diverse Populations <ul> <li>Committee confirmed trainings meet the needs.</li> </ul> </li> <li>Transgender, Gender Diverse Inclusive and Affirming Care <ul> <li>Interest in extending discussions about transgender issues to schools, supporting children in community.</li> </ul> </li> <li>When committee was asked if they have any other suggestions or recommended trainings, committee members suggested trainings on Women's Health/Women's Pain (Member feels women's pain isn't taken seriously), stress/anxiety/depression, treating people with IDD/DD, and housing insecurities. When committee was asked what health-related social needs should be addressed, the committee shared challenges related to the accuracy of provider availability, long wait times to see providers, and helping older adults complete medical forms.</li> </ul>	N/A	N/A

Health Net requested the committee's feedback on the development and implementation of an annual outreach and education plan for Members and PCPs about covered NSMHS.</li> <li>Committee said providers aren't following up.</li> <li>Need for more detailed provider directories, including specialties.</li> <li>Suggested digital communication: emails, texts.</li> <li>Calls for transparency about service availability and better education materials for community outreach.</li> <li>Desire for an easily accessible list of covered providers.</li> <li>Reference the national institute for MH and SUD administration have ways where you can order individual or large quantities of materials.</li> <li>Use social media (TikTok, IG Reels, Facebook).</li> </ul>		
Population Needs Assessment & Local SMART goal	<ul> <li>Sydney Turner shared information on the new Population Needs Assessment, which is a collaboration with other plans and local health department to identify the priority needs of the community. Tina Hendizadeh (Service Coordination Liaison) shared Los Angeles's SMART goal with the committee and requested feedback – From January 2024-December 2025, all county health plans including HN will collaborate with the LHDs (there are 3) to implement strategies to reduce maternal and infant mortality disparities for Black and Native American members in LA county by 50%.</li> <li>Committee suggested gym memberships as a beneficial intervention for pregnant women.</li> <li>Suggested improved understanding of special needs among healthcare providers (OBGYNs, hospitals) to facilitate better care.</li> </ul>	N/A	N/A
