CAC Recommendations Update	Sydney Turner (Director, Public Policy) gave the Committee an update on recommendations received by the CAC:  • The Member Rights One Pager is in progress and pending final edits.  • Last quarter, Committee members requested for a call back feature when calling the Plan's call center instead of waiting on the line. Health Net will be implementing this system in 2026.  • Committee members are requesting for a resource that will assist members in identifying LGBTQ+ providers. Population Health Campaigns	Tarjani Padmani (Manager, Clinical Pharmacy Services) reviewed the outreach campaigns focused on helping Members achieve the highest level of health.  • When asked about what support providers need from Health Net, Committee member expressed interest in more information on ECM.  • Committee members shared their experience about how the list of available providers can be inaccurate. Though the Plan has lists of avail providers, sometimes those providers don't accept new patients or may not treat the Member's issue.  • The Committee also shared a preference to receive information electronically (email, text, Member portal), currently the Plan sends a lot of information by mail.
